Board Meeting Notes – IPSSA, Inc. – Region 7 Tuesday, April 23, 2002

Treasurer's Report: Brian Davis -- as of 4/23/02, checking account balance was \$1,524.14, savings \$5,629.21, Picnic Account \$5,621.71, and CDs \$7,432.42. Will check balance in Emergency Fund.

Benevolent/Region Emergency Fund Report: Ray Duchene -- since January 1, 2002 there have been four deaths in IPSSA Inc., none in R7; each spouse has received \$2,000. Balance is \$33,941.72, with \$23,956.29 available for distribution.

NSPI Liaison Report: A. J. Wilson - NSPI held its region meeting 3/15, with the Strategic Planning Committee meeting the night before. NSPI is working on ways to increase membership and align itself more with IPSSA. NSPI members are mostly pool builders, and IPSSA members are more service oriented, so they are not really in competition and can work better together than separately. Pool builders and service techs are starting to listen to each other. NSPI plans to offer the TECH I & II courses at the WPSS and PIE trade shows. Next region meeting 6/13 - 14 in the Sacramento area. NSPI San Diego chapter met 4/9; next meeting 5/14.

SDG&E: Mary M. Bushy, SDG&E rep - statewide rebate program in 2001 was a huge success. SDG&E paid \$1.5 million in rebates; 5,000 pump conversions, and 15,000 changed time of day for pool pumps. Obviously, the pool industry played a huge part in the success, and she commended IPSSA for its help. The SDG&E program would not have worked without the help of the pool industry, a great group of professionals.

This year's program, effective 4/1/02, will be vastly different -- rebates to single family dwellings, \$100 on single-speed pumps, \$250 on two-speed pumps. Spas included only if they are on the same system as the pool pump. Mary

will try to visit all R7 chapters to explain the program and how to fill out the application forms. Willing to set up conference calls to answer questions. Get forms on SDG&E's web site.

Needs feedback from R7 on energy demands for two-speed pumps. Studies so far indicates that running them at the lower speed, even for longer periods of time, *does* reduce energy. Emergency Fund: Rick Bishop - the purpose of the Emergency Fund is to provide financial assistance to individuals in the pool industry who are in need due to illness, accident, death, or serious misfortune. Sources of money to the Fund are: 25% of the monthly Region dues, donations from individuals and chapters, and R7-sponsored fundraisers, such as the Silent Auction held at the annual R7 picnic. Rick Bishop asked for donations of used pool items for this year's Silent Auction and requested other ideas to raise money for the Fund.

A. J. Wilson pointed out that because IPSSA is a non-profit organization, it is not allowed to accu-

multate too much money in the Fund; there is a cap of \$10,000. Rick said that according to the CPA for IPSSA, Inc., there is no reason to have a cap as long as we don't limit the funds to just IPSSA members. Motion carried to remove the \$10,000 cap from the Emergency Fund.

Kids' Bikes: **John Baldwin** -- for 30 years a man in National City has been collecting and refurbishing old bicycles and skateboards to distribute to needy kids during the Christmas season. He has non-profit status. John proposed that R7 members do a one-month bike drive during the month of June. Superior Pools San Diego has agreed to store the donated bikes for delivery to the man in National City. It was suggested the other Superior sites in El Cajon and Escondido be used as drop-off points; the bikes can then be delivered to National City.

John will prepare a flyer for **Nancy Gillespie** to include in the R7 newsletter; members can then copy the flyer and disseminate to their customers. To get the word out, perhaps we can get media coverage. John has a video about the man; he will make copies for vendors to play in their stores. The man can handle 200 bikes, prefers bikes 26" and under.

Picnic Report: **Don Wall** has scheduled the annual R7 picnic for Sunday, 8/18/02 at Mission Bay Park. Theme - "Stars and Stripes Forever."

Director's Report:

1. 4/12/02 BORD Meeting -- **Mike Gregg** -- BORD passed a resolution requiring employees to also be water chem certified. Our insurance rates reflect what we and our employees do; if our employees know as much as we do, we are in better shape.

2. Water Watcher Tag Program -- **Jon Rumble**, SD chapter, is working to promote the tags. Jon is getting developers and pool builders to purchase them, and he is working with the PTA. A Safe Kids Coalition rep was recently on TV and mentioned the tags and IPSSA.

Motion carried to give **A. J. Wilson** 1,000 tags to distribute at his booth at a 5/23 trade show to get the tags into the hands of the public to educate them; any tags remaining will be returned to R7.

3. Social Chairman (previously **Don Wall**) -- Nominations are needed for Social Chairman.

4. Swimming Pool Regulations -- The Department of Health Services is revising the existing swimming pool regulations. If you want a copy of the draft revisions, contact **Mike Gregg**, and he will e-mail a copy to you.

R7 Emergency Fund

Purpose: To provide financial assistance to individuals who are in IMMEDIATE financial need due to an illness, accident, death, or a serious misfortune. This fund is designed to assist only and should not be expected to fully compensate the recipient's needs.

Eligibility: Pool and spa industry personnel, and their immediate family residing in the San Diego County area. To be determined by the Regional Emergency Fund Committee (REFC) comprised of the Region rep, one chapter president from the metro portion of the County, and one chapter president from the northern portion of the county.

Request: Requests for emergency assistance may be made to the REFC by any pool or spa service personnel residing in the San Diego County area.

Award: The payee and the amount of the award shall be determined by a 2/3 vote of the R7 Board upon recommendation from the Region Emergency Fund Committee.

Urgency: Should the need for funds exist, the Region director may call a special meeting of the Board for the sole purpose of acting on a request for emergency assistance. Notification of a special meeting shall be made within 48 hours either by phone or fax.

Disbursement: A check prepared by the Region treasurer shall be presented to the recipient or to the recipient's family.

Source of Funds: 25% of the monthly Region dues. Also monies shall be generated from individuals, chapter donations, and from R7 sponsored fundraisers. Said monies shall be maintained by the Region treasurer in a separate, interest-bearing account titled "Region 7 Emergency Fund."
