PRESIDENT'S BRIEFS

It was nice to see so many of you at the picnic in August. The effort put forth by the region 7 picnic committee was greatly appreciated and a good time was had by all!

The Ipssan newsletter presented two major issues that we will discuss at the upcoming chapter meeting. One proposes replacing the benevolent fund with an increase in life insurance from \$30,000 to \$50,000 for members under 70. Net increase in dues would be \$3.25; or replacing the benevolent fund with an increase in life insurance from \$30,000 to \$50,000 and adding an accidental death benefit of \$100,000. Net increase in dues would be \$5.10.

The second issue presented is a

ballot measure that would allow the Regional Director to serve with no term limits. Currently Region Directors may serve 2 terms within a 10-year period.

See all of you at our next meeting on September 19th. Remember that our October meeting will be a mandatory one and we will be nominating and voting on new board officers for our chapter. If you are interested in becoming an officer, please call me at 619-224-3863.
