Director's Notes

Region 7 Quarterly Report

1. **Tax Data** – I am glad to announce that all chapters in Region 7 had their tax data in on time and qualified, although one chapter needed a last minute reminder. In all of IPSSA only about five chapters threw free money away.

By now all chapters should have received their \$40 per member from IPSSA. It should have been directly deposited into your chapter's bank account. For chapters without an account, your treasurer should have received a check. Again let me encourage you to donate all or part of the free money to SPEC and/or a charity of your choice.

2. **BORD** – The May 14 BORD meeting had two critical Issues to deal with, both to do with insurance. Actually, only one was critical – the necessity to separate IPSSA sponsored insurance as a membership requirement. This is considered “bundling” and is a violation of the anti-trust laws. This had just recently

come to our attention, and thank goodness we have not been audited since we made the separation of IPSSA/IPSSA Management Co. You are now free to get your insurance from other than Arrow Insurance, provided it meets minimum standards. However, for the money there is not a more comprehensive policy available.

The second issue had to do with unequal dues billing, which came about because different states have different tax rates on insurance premiums. This has been resolved by achieving the same dues for all states. Some states increased by pennies and others dropped by pennies.

3. **Election** – Remember this is an odd numbered year and requires election at the region and chapter level. Nominations for Region 7 Director will be accepted at the June 22 Region meeting and close on September 1. All potential candidates should consult the current director for a job description prior to the September Region Meeting. The election will take place at the September Region Meeting. All chapter elections should be held prior to October 15. Remember that the bylaws require each chapter to elect/appoint a second representative to the Region Board in addition to the president.

4. **B.K. Taylor Award** – Be thinking about your chapter's nominee for the B.K. Taylor Award. Application forms are available by contacting the Region Director. A decision will be made at the September Region Meeting.
