Take Harbor Drive to Laurel Street. Laurel to I-5 North (follow Fwy signs). Exit I-8 East (El Centro Fwy) and immediately merge into right lane. Exit Hotel Circle/Taylor Street and turn left onto Hotel Circle South. Hotel is ¼ mile down on the right.

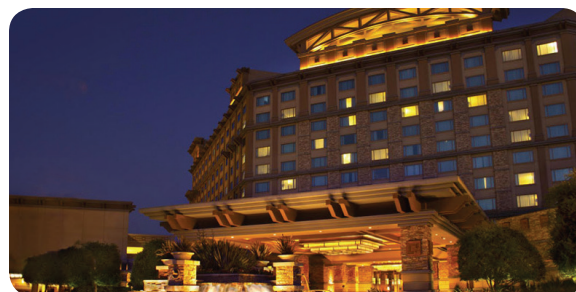
