Welcome everyone to the last meeting for the second quarter for June. Apologize for my absence the last couple of weeks for those that have been trying to reach me as I lost two close family members, and to top it off, I thought I was coming down with a cold and tested positive for Covid. Feeling much better these days and waiting for two negative results in a row.

Yes, I am going to talk about the subject again, gas prices! I have experienced another 35 cents increase in gas prices since the last Skimmer was published, and there is another week to go before we have our next general meeting... I understand we have no control over this expense but it affects how we make decisions for our businesses.

I'm sure we all are experiencing part delays from manufacturers and it's a very complicated process with wholesalers. It took me four and half months to acquire a






simple circuit board to repair a chlorine generator. I have clients that authorized me to install new chlorine generators, but availability is scarce. One distributor told me none available in San Diego and Orange County. I asked Leslie's Pool Supply and was told it would not be available until late 2023.

Paul Grimes gave the board a great presentation on the website status that he and Gary Roberts are working on. This website presentation will be offered at general meetings for review and discussions.

The guest speaker for the June general meeting will be the California Highway Patrol to provide guidelines and laws regarding transportation of hazzard materials we use in our trucks every day. We currently have no guest speaker scheduled for July, but for August Hayward is scheduled for continuing education points before the General Meeting.
